Services and Payment

Most of our hunts include meals and lodging with the exception of Oryx and some Antelope hunts. All hunts **do** include transportation in the field during the hunt, skinning of game, and delivery of game to cold storage, and are guided two hunters per guide unless otherwise stated in the S.O.HUNTS Outfitter & Guide Service contract. State hunting licenses (even if the Hunter is hunting with a landowner permit), taxidermy, meat processing, and airport pick up and return are **not** included unless otherwise agreed upon between hunter and S.O.HUNTS and is stated in the contract. A 50% deposit is required to book your guaranteed license/tag hunts. If the hunter so chooses, S.O.HUNTS will apply the hunter in the lottery drawing every year until the hunter is successfully drawn for a license/tag. **On all hunts in New Mexico, 7% gross receipts tax will apply and is added to the listed price of the hunt. A 50% deposit is required at time of booking. Final payment is due prior to any hunting activity**

Liability/Photo Release

In consideration for my being permitted to participate in the activities of S.O.HUNTS Outfitter & Guide Service, I agree to the following waiver and release. I acknowledge that hunting and other wilderness activities have inherent risks, hazards and dangers for anyone, that cannot be eliminated, particularly in a wilderness environment, I understand that these risks, hazards and dangers include without limitation: 1) Activities involving rugged country; 2) Encounters with wildlife, animals and insects; 3) Activities involving wilderness travel and camping; 4) Inclement weather conditions; 5) ATV's and other vehicles; and 6) Activities involving bows/arrows and firearms. I understand the risks, hazards and dangers described above and have had the opportunity to discuss them with S.O.HUNTS Outfitter & Guide Service. I understand that these activities may require good physical conditioning and a moderate degree of outdoor skills and knowledge. I believe I have good physical conditioning and the degree of outdoor skills and knowledge for me to safely engage in these activities. I understand that I have responsibilities. I am voluntarily using the services of S.O.HUNTS Outfitter & Guide Service with full knowledge of the inherent risks, hazards and dangers of the activities described herein. I hereby assume and accept any and all risks of injury, paralysis or death. Lastly, I, for myself, my heirs, successors, executors, and subrogates, hereby knowingly and intentionally waive and release, indemnify and hold harmless S.O.HUNTS Outfitter & Guide Service, their directors, officers, agents, employees and volunteers from and against any and all claims, actions causes of action, liabilities, suits expenses (including reasonable attorney's fees) which are related to, arise out of, or are in any way connected with my participation in these activities.
